- Announced expansion of thermoplastic co-polyester production unit in Ferrara, Italy to support continued growth in Engineered Materials.
- Announced expansion of Clear Lake methanol production to 1.7 million metric tons per year in support of the global reconfiguration of the acid production footprint.
- Commercialized 1,075 Engineered Materials projects in the first quarter of 2019, a
  45 percent increase year over year.

#### **Lithium Ion Batteries**




- Lithium ion batteries increasingly proliferate digital consumer device and electric vehicle applications

- Celanese offers localized customer solution centers with membrane processing and testing capabilities







Net sales (in millions)


Total segment income margin







#### **Share Repurchases**

- Deployed \$200 million in Q1 2019 to repurchase ~2 million shares
- ~\$500 million remaining share repurchase authorization as of March 31, 2019
