Topic: Borussia Dortmund announced to have signed an agreement to sell youngster Jude Bellingham for up to \in 134m, resulting in an expected \in 77m positive EBITDA.

Following numerous rumors regarding the future of Jude Bellingham, BVB stated that his transfer **to Real Madrid is now about to be finalized.** The realization of the transfer should therefore only be subject to the proper and timely processing in accordance with the provision of the FIFA Transfer Matching System as well as mandatory medical check. However, this should not be more than a mere formality.

Once the deal is sealed, **Real Madrid will pay BVB a fixed transfer fee of € 103m**. On top of that, the **contract includes variable components, which could increase the fee by up to 30%** (\in 30.9m), depending on the achievement of certain sporting successes (e.g. Champions League win) and performance of the player (e.g. certain amount of scorer points) during the next six seasons. Considering the reported transfer fee of \in 30m, which BVB paid for Bellingham in 2020, this once again **underpins the success of the club's scout & develop strategy.**

Management expects that the transfer will have a € 77m positive EBITDA effect in the 2023/24 fiscal year. However, as we expect the club to replace Bellingham by buying a new player as well as adding at least one further player to compensate for the departures of Mahmoud Dahoud and Raphael Guerreiro, who will both leave for free, our estimates only include a € 28m EBITDA increase. Moreover, we do not include the variable components of the deal in our model, leaving some upside to our estimates.


While Bellingham has been a crucial part in BVB's sporting success during recent years (21 scorer points during last season alone), we are convinced that the club will be able to adequately replace him thanks to the excellent scouting department. BVB should therefore be in a position to once again fight for the championship next season as well as to achieve a good result in the champions league.

Valuation continues to look undemanding, as **the stock is trading at only 0.9x EV/Sales 2022/23e**, **thus on a notable discount to its peers** Juventus (1.5x) and Manchester United (4.1x).



The determination of the fair value per share, i.e. the price target, and the resultant rating is done on the basis of the adjusted free cash flow (adj. FCF) method and on the basis of the discounted cash flow – DCF model. Furthermore, a peer group comparison is made.

The adj. FCF method is based on the assumption that investors purchase assets only at a price (enterprise value) at which the operating cash flow return after taxes on this investment exceeds their opportunity costs in the form of a hurdle rate of 7.5%. The operating cash flow is calculated as EBITDA less maintenance capex and taxes. Within the framework of the DCF approach, the future free cash flows are calculated initially on the basis of a fictitious capital structure of 100% equity, i.e. interest and repayments on debt capital are not factored in initially. The adjustment towards the actual capital structure is done by discounting the calculated free cash flows with the weighted average cost of capital (WACC), which takes into account both the cost of equity capital and the cost of debt. After discounting, the calculated total enterprise value is reduced by the interest-bearing debt capital in order to arrive at the equity value.

NuWays AG uses the following three-step rating system for the analysed companies:

Buy: Sustainable upside potential of more than 20% within 12 months

Sell: Sustainable downside potential of more than 20% within 12 months.

Hold: Upside/downside potential is limited. No immediate catalyst visible.
